In power generation, industrial processes, parts of the transportation sector, and for domestic use, natural gas still has the potential to play a greater role in various energy transition pathways around the world. But such a future is by no means certain. In this book, Michael Bradshaw and Tim Boersma offer a sober and balanced assessment of the place of natural gas in the global energy mix today, and the uncertainties that cloud our understanding of what that role may look like in the future. They argue that natural gas has become prominent in recent decades, spurred by two revolutions: the first has been the rise of unconventional natural gas production, and the second the coming of age of the market for liquefied natural gas (LNG). However, a third revolution is required to secure natural gas ’ long-term role in various energy transition pathways, as countries are increasingly pushing to address air quality concerns and curtail greenhouse gas emissions. This revolution has to take place as politicians, citizens, investors and shareholders are becoming increasingly vocal about the need to improve the environmental footprint of the fuel, while simultaneously, and perhaps paradoxically, demand for it continues to grow, in a world where geopolitical challenges seem to be mounting.

This paper focuses on the Doha Development Agenda. The paper highlights that over the past 20 years, world trade has grown twice as fast as world real GDP, deepening economic integration and raising living standards. The paper underscores that the launch of a new trade round in Doha in November 2001 was a

major breakthrough following the debacle in Seattle in 1999. The new round places the needs and interests of developing countries at the heart of its work, but a successful outcome for rich and poor nations alike is by no means a foregone conclusion.

This book examines the development of Uzbekistan ' s international relations since the collapse of the Soviet Union.

The book explores how the European Union and its members have been renegotiating Europeanisation and renationalization in response to the multiple crises they faced over recent years. The authors highlight varying understandings of ' crises ' in different national and supranational policy and institutional contexts. They show how in some cases these have challenged the legitimacy of European Union norms and institutions and even triggered disintegration, while in others these crises have served as sources of inspiration for European social innovation and political development.

This edited collection highlights the different meanings that have been attached to the notion of energy security and how it is taken to refer to different objects. Official policy definitions of energy security are broadly similar across countries and emphasize the reliability and affordability of access to sufficient energy resources for a community to uphold its normal economic and social functions. However, perceptions of

energy security vary between states causing different actions to be taken, both in international relations and in domestic politics. Energy Security in Europe moves the policy debates on energy security beyond a consideration of its seemingly objective nature. It also provides a series of contributions that shed light on the conditions under which similar material factors are met with very different energy security policies and divergent discourses across Europe. Furthermore, it problematizes established notions prevalent in energy security studies, such as whether energy security is ‘ geopolitical ’ , and an element of high politics, or purely ‘ economic ’ , and should be left for the markets to regulate. This book will be of particular relevance to students and academics in the fields of energy studies and political science seeking to understand the divergence in perspectives and understandings of energy security challenges between EU member states and in multilateral relationships between the EU as a whole.

By taking stock of the implementation of the EU ’ s Global Strategy and the five principles that are guiding EU-Russia relations, this volume contributes to a better understanding of the current EU-Russia relationship and the prospects for overcoming the existing deadlock.
