This chart identifies sensitivity levels applied to all federal jobs and most federal contractor jobs. It shows the related application forms, investigations, security/suitability clearance determinations, and reinvestigations. Some jobs are designated as both Public Trust and National Security positions.

Federal Suitability/Security Clearance Chart

If a person has passed a suitability screening with the federal government it does not indicate they will also be able to obtain a federal security clearance. Suitability determinations are often used by the federal government and government contractors in initial applicant screenings.

An individual's security clearance is not technically transferable.

Rather, most agencies will rely upon a sister agency's adjudication of a security clearance so long as it is active and the agency has not received derogatory information calling into question the individual's suitability to have access to classified information.

The major problem for an applicant seeking a security clearance is that, regardless of state laws, marijuana is still illegal at the federal level. Use, possession, and transportation of marijuana, as well as association with marijuana users, and several other factors can potentially disqualify applicants for a security clearance.

Mitigating Marijuana Issues for New Security Clearance ...

Security clearances only apply to positions that fall under the purview of the federal government. Executive Order 12968, Access to Classified Information, provides that security clearances are only granted to persons employed by, detailed or assigned to, or working on behalf of the federal government.

Security Clearances - United States Department of State

Security clearances can be issued by many United States of America government agencies, including the Department of Defense (DoD), the Department of State (DOS), the Department of Homeland Security (DHS), the Department of Energy (DoE), the Department of Justice (DoJ), the National Security Agency (NSA), and the Central Intelligence Agency (CIA). DoD issues more than 80% of all clearances.

Title 5 Code of Federal Regulations Part 731 governs federal employment suitability standards and procedures. Section 731.202 of 5 CFR 73 covers specific suitability criteria. The "Adjudicative Guidelines for Determining Eligibility for Access to Classified Information" governs federal security clearance criteria.

Employment suitability and security clearance criteria are very similar, but a few differences exist.

About 3 million jobs require a security clearance and over 800,000 investigations and reinvestigations are conducted each year. 2. Federal Employment Suitability and Fitness regulations require all federal employees and contractor applicants for Public Trust positions be investigated and receive favorable suitability or fitness determinations. About 400,000 investigations are conducted a year for this purpose.
