Enforcement orders are dealt with under Section 11J of the Children Act 1989. Paragraph 2 of that section says: If the court is satisfied beyond reasonable doubt that a person has failed to comply with a provision of the child arrangements order, it may make an order (an “enforcement order”) imposing on the person an unpaid work requirement.
