An attorney can also commit malpractice by breaching a contract or a breach of fiduciary duty owed to the client. In a legal malpractice lawsuit, a plaintiff must plead and prove (1) the existence of an attorney-client relationship (i.e. the lawyer owes the client a duty); (2) a breach of duty arising out of that attorney-client relationship; (3) that the breach proximately caused damages to the plaintiff client; and (4) damages as the proximate result of the lawyer's
