On March 20, 2020, the New Mexico Superintendent of Insurance issued BULLETIN 2020-006 to all admitted and non-admitted insurance companies that provide any insurance coverage in New Mexico (including life, health, auto, property, casualty, etc.) requesting them to refrain from cancelling or non-renewing policies of businesses and individuals due to the nonpayment of premiums during this public health emergency, or at a minimum, provide extended grace periods for payment of premiums.
