The right to privacy. Prisoners have no Fourth Amendment right to freedom from unreasonable search and seizure.

Prison officials can monitor prisoners' movements throughout prisons, watch prisoners in their cells, and conduct warrantless searches inside prisons. In *Hudson v. Palmer* (1984), the Supreme Court ruled that prisoners have no reasonable expectation of privacy in their prison cells entitling them to Fourth Amendment protection.
